



Trent Pettigrew

Please Welcome Our New Academy Coordinator

Trent Pettigrew comes to CLEET from the Canadian Valley Technology Center as the Director of Safety and Security. He was tasked with creating and developing a "BPOC" Basic Peace Officer Certification Academy for Canadian Valley. They started with nothing but a classroom and were given a budget. Trent began the first BPOC academy in January of 2023, emphasizing Discipline and Structure, and graduated some outstanding Cadets. The academy still operates on the same framework to this day. Trent served 29 years as a State Trooper, retiring as a Captain/Troop Commander. He started his career in Troop K Stillwater before being assigned to the Special Operations Criminal Interdiction Unit. He spent most of his career as a Criminal Interdiction Trooper and K-9 handler with my K-9 Rocky. He was the Criminal Interdictor of the Year twice and the Criminal Interdiction Team of the Year three times. He also taught Criminal Interdiction techniques around the United States, teaching for the DEA and DIAP. Trent also taught classes in Search and Seizure, vehicle Compartments, K-9 use, Courtroom Testimony, Body Language, and Statement Analysis. Trent is an expert in body language and statement analysis in Oklahoma. He also wrote a book on lie detection and statement analysis basics. As a Trooper, he served as an OHP academy TAC Officer in several academies and taught Criminal Patrol Techniques in virtually every academy since 1995. He also teaches firearms and attended the Gracie Academy in 1995. Trent was promoted to Lieutenant, where he was the night shift Lieutenant for the metro, Troop A. A few years later, he was promoted to Captain/Troop Commander over Troop A, where he was the youngest Commander ever of Troop A and one of the longest servings. In addition to Troop A, he was the Commander of the Communications Division. He retired as the Commander on the turnpikes, Commanding the Bailey, Turner, Kilpatrick, and Cimarron turnpikes before my retirement in 2022. In January of 2023, his family began constructing their "forever" home on our farm near Calvin, Oklahoma, and moved to SE Oklahoma. Hence, the Academy job at CLEET. CLEET hired him in March of 2023 as the CLEET Academy Coordinator/Manager. "Director Stacy gave me his vision for the future of the CLEET academy, and we are in perfect alignment. We are on a mission to make the CLEET academy the Premier law enforcement training academy in the country". Trent is married to his wife of almost 28 years, Christy, who is a Dentist/Hygienist in Yukon and shares two children: Paige, a recent graduate of UCO and case manager at a large law firm in Oklahoma City, and Trevin, a freshman baseball player at Murray State College in Tishomingo. Trent has Degrees in Criminal Justice and Business and a master's degree in management. He is also an adjunct Instructor for Southern Nazarene University in Oklahoma City. He enjoys hunting, fishing, ATVs, watching college baseball, and traveling in his spare time.



The Legislature is back in session with dozens if not hundreds of bills filed that may have some effect on Oklahoma peace officers from amendments to existing criminal statutes, proposed new crimes and punishments, changes to pension plans, and so much more. CLEET's legal office will be monitoring the session and tracking bills that make it through so they can be included in the 2024 legal update this summer. Speaking of legal updates, for those of you who have not had a chance to take the 2023 legal update it is still available in a variety of ways. First, the written materials are available and open to anyone on our website. You can find them by going to the "CLEET Training" tab on the banner at the top of the home page, engaging the drop-down list and selecting "Legal Updates" at the bottom of the list. That will take you to the legal updates page and the materials for 2023 and the last several years are available on that page, just click on the desired year. Also on that page are three on-demand CE courses covering the 2023 legal update materials. You can take one, two, or all three of the courses. Each is worth one hour of CE. Just click on the link that says "2023" Legal Updates are now available" and it will take you to a separate page where you can select whichever courses you'd like to take. If online training isn't your thing, there are currently three opportunities on the calendar to attend a 3-hour legal update CE course in person. If anyone is interested in hosting a legal update this year, feel free to reach out directly to Preston Draper at preston.draper@cleet.state.ok.us. Finally the "legal block" in the fulltime basic academy is back in person rather than online this year. Instead of running all of the lectures together over 5 or so back-to-back days like we used to do, we will be breaking the legal materials up into single days spread across the length of the basic academy. We hope the new approach will be conducive to better comprehension and retention of the serious topics contained in the legal block.



During the past month, We have had the opportunity to engage with Chiefs and Sheriffs at our monthly meetings. These sessions have been productive in discussing key issues and collaborating with stakeholders from the OACP Board, OSPOA, OSA Board, and the Regional OSA Committee. Attending CLEET Council meetings, PSAC meetings, Rules meetings, and other Committee meetings have presented valuable opportunities to interact with Council and Committee members. These interactions are crucial in fostering relationships and addressing concerns effectively. In recent weeks, we have attended numerous in-person meetings with Private Security Agency Owners, Private Investigator Agency Owners, and Private Security School Coordinators. These interactions have been instrumental in understanding their perspectives and enhancing collaboration within the industry. We have initiated investigations on Private Security and Private Investigator licensees during our work. These efforts are aimed at upholding industry standards and ensuring compliance with regulations. Conducting on-site inspections of Private Security and Private Investigator Agencies and Private Security Schools remains a priority. These inspections are essential for monitoring operations and enforcing regulatory requirements. Regular meetings with the Legal team to address complaints received via the Portal have been productive. We strive to ensure we are meeting the needs of all security professionals around the state.



CLEET Certification/License Hard Cards are back! CLEET staff have been printing the backlog of anyone who gained certification or license during the transition into CLEETs new system, Thentia. The Full-time and Reserve peace officer certification cards are current with the success in printing from the Law Enforcement records team. The Private Security team has printed over 3,000 hard cards from the back log of new licenses, upgrades, and renewals. The Private Security team has approximately 2,000 left and printing daily. CLEET is excited to inform you that the process for duplicate hard card requests is at your fingertips through the online Licensee Portal by completing a Document Request. Once CLEET receives your request, you will be invoiced a fee for your duplicate hard card of \$10. (Please note the printable card and valid hard cards used in past are still eligible for proof of licensure or certification.)
