**Discussion and possible action on recommended renewal of loan: *Study for Pro Patria* by Thomas Gilbert White from the Wollaroc Museum and Wildlife Preserve and the Frank Phillips Foundation.**

The artwork is located next to the portrait of Frank Phillips. This piece is only on a one-year loan and this would be the second loan extension.

**Collections' Manager Report**

Clint Stone gave an update on some of the current projects. The fabric walls in the temporary galleries will be changed out and completed before session starts.

The Allan Houser at the Capitol: A Legacy in Bronze exhibit will be held January 15 through December 15, 2014 on the ground of the Capitol. Five monumental works will be on display. There will be a dedication on March 10<sup>th</sup> with a tour led by Dr. Blackburn.

The Ralph Ellison portrait will be dedicated tentatively on March 6<sup>th</sup>.

**Discussion and possible action on consideration of monument moratorium.**

Chair Thompson read his motion in full as follows: Earlier this year the ACLU brought a law suit against the Capitol Preservation Commission regarding the placement of the Ten Commandments Monument on the north lawn of the Capitol. Since that time the CPC has received numerous requests from individuals and groups seeking to place additional monuments on the grounds. At this time, I believe action by the CPC on any of these requests would be premature given that the lawsuit has yet to be decided. Therefore, I move the CPC place a moratorium on consideration of all monument requests for the State Capitol and its grounds until the lawsuit has been adjudicated.

Chair Thompson stated that because there is a pending lawsuit, there can be no discussion or comments regarding the motion itself.

Ms. Edmondson wanted to remind the commission that a precedent was set a year ago when there was a moratorium placed on accepting new interior artwork for the Capitol.

Ms. Edmondson made a motion to accept the item as proposed. Ms. Kerr seconded the motion.
