**Agenda Item 8 – Chairman Report [Trait Thompson]**

- **Update on the Ten Commandment Monument**

Chairman Thompson stated for the record that an update was just received on the Ten Commandments litigation. The monument was just recently damaged. It was reported that a replacement monument has been privately donated by the same people who donated initially. It is the understanding that it will be identical in all respects and the Division of Capital Assets Management (DCAM) / Office of Management and Enterprise Services (OMES) will be working with the donors on a time for reinstallation.

- **Update on Capitol Restoration Project**

Chairman Thompson congratulated Cara Rodriguez, Assistant Solicitor General, for representing the state in the lawsuit against the bond issue for the capitol project. The court sided with the state.

An announcement of the contractor that won the award to fix the exterior of the capitol building will be made on Monday, and WJE and Associates, consultants to the project will announce their final report.

The Capitol Oversight Committee met last week and approved their preliminary plan to be submitted to OMES that included their goals and criteria for the interior project. They are currently in the process of selecting a vendor that will repair the interior of the capitol building.
