<u>Agenda Item 1</u> – Determination of quorum and call to order. [Linda Edmondson, senior member acting as chair]

Ms. Edmondson called the meeting to order at 10:35 a.m. A roll call was taken and a quorum was established. She was advised that notice of the meeting had been given, and an agenda posted in accordance with the Open Meeting Act.

Ms. Edmondson told those present the reason for the special meeting was determined by the recent order of Judge Thomas Prince, District Court, Oklahoma County. On Sept. 11, 2015, Judge Prince issued an order that the Ten Commandments monument be removed from the grounds of the Oklahoma State Capitol by the Capitol Preservation Commission (CPC) within 30 days. The monument was placed by CPC as required by legislation that was passed in 2009. It was paid for with private funds.

The CPC was sued about the monument and the case worked its way to the Oklahoma Supreme Court. The court found that the monument was religious in nature and thus violated article II, Sec. 5 of the Oklahoma Constitution, called the Bill of Rights, that states, "No public money or property shall ever be appropriated, applied, donated or used directly or indirectly for the use, benefit or support of any sect, church, denomination or system of religion." The Supreme Court remanded the case to Judge Prince, who issued the order.

Because the regularly scheduled meeting is not until Oct. 15, 2015, a special meeting was called today to respond to the judge's order.

Ms. Edmondson further explained the reason why she's presiding, because the commission's chair and vice-chair have both resigned recently for reasons unrelated to the monument. As new officers have not been nominated or elected, it was advised by the AG's office that a senior member could preside. The most senior member having declined, Ms. Edmondson, being next in line, agreed to preside.

Agenda Item 2 – Discussion and possible action to enter into executive session pursuant to 25 O.S. §307(B)(4), for the purpose of confidential communications between the commission and the commission's legal counsel regarding Prescott v. Oklahoma Capitol Preservation Commission, Oklahoma County District Court case no.
