**1. Determination of quorum and call to order. [Vickie Hicks]**

**4. Announcement of new Chairman of the Art Standards Committee. [Vickie Hicks]**

Mr. Pickel, preceded by Linda Edmondson, received a warm welcome from the Commission as the new Chair of the Art Standards Committee. He reported that the Committee is designated as the steward of placement for all artwork in the Capitol.

**5. Discussion and possible action to temporarily remove and restore the Constance Whitney Warren statute “*Tribute to the Range Riders*,” for repair and reconditioning. [James Pickel]**

Mr. Pickel conveyed on behalf of the Committee that the statue has suffered infiltration of water where holes have manifest in the sculpture causing severe corrosion to the internal support structure. The concern for the integrity of the interior structure and overall poor condition of the patina warrants imperative action. The bronze sculpture is the oldest piece of artwork on the Capitol grounds and is in disrepair and in dire need of restoration. Ms. Sharples, Executive Director of the Arts Council and her team chose a foundry in Texas with considerable expertise performing repairs such as this. The State Capitol Centennial Committee will fund the repair and restoration of the piece of artwork, with the total cost being \$33,700.00. The Art Standards Committee recommended the Commission to approve of the temporary removal for repair and reconditioning.

Mr. Ross moved to approve and accept the proposal. Mr. Mass seconded the motion. The motion passed and the following votes were recorded:

**6. Collections Manager Report. [Alan Atkinson, Director of Visual Arts and Capitol Collections]**

**– Removal of four governors bust from the Capitol for safety issues during the renovation.**

Mr. Atkinson reported the busts were removed safely from the Hall of Governors and were transported to a secure storage facility in Oklahoma City. The bust of Governor Fallin was temporarily removed up to the waiting/reception area outside of her office.

**– Future plans on improvements to the lighting for Capitol artworks.**

Mr. Atkinson reported that future lighting for the artworks in the building will be replaced with light-emitting diode (LED) lighting. The Betty Price Gallery will have new flexible lighting to dim or brighten the lights as appropriate for the artwork.
