Mr. Bauer gave a report on 2018 incentives (year three) under consideration for evaluation this year. The members received a document that was reviewed in the presentation of the meeting. He gave a synopsis of the fourteen incentives and explained the spreadsheet flow. See below:

- Program Name: Incentive
- Program Administrator: e.g., State agency, commission or department
- Program Type: e.g., Tax credit, tax exemption, loan/loan participation, grant/reimbursable, equity investment(s), closing fund.
- Estimated Incentive Cost: As previously, carried forward from the original documentation created to schedule out the various incentives. This category will continually have revisions made to it.
- Incentive Description: Comes from the original document.
- Possible Criteria for Evaluation: Specific areas to evaluate related to HB 2182 that created the evaluation process.

Some revision edits were made to the document for accuracy. The Quality Invest Program name changed to the Quality Jobs Investment Act (QJIA) and the program administrator of that Act changed to the Oklahoma Housing Finance Agency. The Affordable Housing Act 14 (AHA14) program administrator changed to the Oklahoma Housing Finance Agency. Originally, the pro-program administrator for both incentives was the Oklahoma Tax Commission (AHA14) and the Oklahoma Department of Commerce (QJIA).
