Discussion and possible action on displaying the 1919 oil painting of TeAta on the 2<sup>nd</sup> floor, north hall

Discussion and possible action on the placement of the Ten Commandments Monument

Mr. Mass told those present that the Architecture and Grounds committee reviewed possible locations for placement of the Ten Commandments monument and selected a site on the northeast side of the Capitol. The monument will face out towards the North Mall and the Oklahoma Tribal Flag Plaza in a serene, reflective setting. Mr. Meyer stated that the placement of monuments and sculptures in this area has been on the Commission's wish list for many years and that the Ten Commandments monument would be the first element in creating what would ultimately be a sculpture garden surrounding the Capitol.

Much discussion was held on the issue of location, as some members of the Commission preferred a site on the south side of the Capitol, closer to the southeast entrance and more foot-traffic.

Votes cast were as follows for the Monument to be placed on the northeast side of the capitol: Richard Ellwanger, yes; Doug Kellogg, yes; Duane Mass, yes; Paul Meyer, yes; John Richard, yes; Louis Trost, no; Dian Wadley, yes; James Waldo, yes; Larry Warden, no; Chad Warmington, no; and Paul Ziriaux, no. Motion carried.
