Determination of Quorum and Call to Order

The meeting was called to order by Larry Warden, Vice-Chair and it was ascertained that a quorum was present.

Discussion and possible action on Minutes of the February 17, 2011 Meeting

Update on the condition report of the State Capitol

Duane Mass reported on the condition report of the State Capitol. Copies of the report were given to the Members. Mr. Mass told those present that this is a working document.

Discussion and possible action of deaccession procedures

Ms. Tate told those present that Section 74-4104 of the State Capitol Preservation Commission statutes, the powers and responsibilities of the Commission include to “establish procedures by which private contributions of suitable art can be accepted for the Capitol and the Governor’s Mansion. The Commission is authorized to accept and make proper disposition of works of art as may be donated to the Commission and this state.”

Legislative Update
