Determination of Quorum and Call to Order

The meeting was called to order by Richard Ellwanger, Chair and it was ascertained that a quorum was present.

Discussion and possible action on Minutes of the April 15, 2010 Meeting

Paul Ziriaux moved approval of the Minutes of the April 15, 2010 meeting. Duane Mass seconded the motion and it carried.

Discussion and possible action on placement of paintings of Lucille Mulhall and Pawnee Bill in the north wing of the fifth floor of the Capitol

Larry Warden moved approval to place the paintings of Lucille Mulhall and Pawnee Bill in the north wing of the fifth floor of the Capitol. It is also requested that the location be approved on a temporary basis due to the impending move of the Courts and any remodeling or changes that might occur on the fifth floor and that hallway. Discussion and possible action on placement of painting of Alexander Posey by artist Mike Wimmer

Discussion and possible action on approving new painting of the Canadian River by Artist Rick Fry

Mr. Warden stated that the painting that is before the Commission today, was previously approved subject to being framed, location to be determined, and that the painting to meet the standards set by the Arts Standards Committee. Representative Nations and Rick Fry addressed the Commission regarding the painting of the Canadian River. Mr. Fry said he was making the changes as suggested to him.

#### Discussion and possible action on current images hanging in the “Oklahoma Postcard Collection”

#### Discussion and possible action on window tinting for the south windows of the Capitol

Mr. Mass showed a sample of the window tinting film that he recommends using to cover the south windows in the Capitol. Mr. Mass told those present the film would help reduce heating and cooling costs and also help stop damage to the artwork, furniture and carpet.

Mr. Richard moved approval to move forward with the request. Mr. Richard said he would work with Friends of the Capitol of pricing, if they feel it is too costly, he will bring back to the Commission for further action. Mr. Trost seconded the motion. Discussion and possible action on installing a one way mirrored glass for room 105 and the interior door in room 104, Capitol for the Governor's transition office.

Mr. Mass the Committee recommended using a heavy tint instead of glass due to the fact the door is one of the original doors in the Capitol. The door would have to be altered in order for the glass to work.

Mr. Warmington reported that some members of the legislature were concerned about the style on the "Beyond the Centennial: mural and its appropriateness in the Hall of Governors. He asked what steps these individuals would need to take to address their concerns with the Commission. Chairman Ellwanger stated that they should follow the Commission's established procedure of submitting a written request to the Chair for placement on the agenda.
