H.1. Pricing

H.1.1. Pricing is based upon price per each for each of the types listed below. It is unknown how many tests will be needed per year on a statewide basis; so, the amounts listed in H.2 through H.5 are estimates. In the past, one Authorized User, the Department of Corrections, has used the approximate numbers per year listed below in H.1.1.1 through H.1.1.4.

H.1.1.1. HSEA Paper Based Tests – Approximately 160

H.1.1.2. Practice or Readiness Tests – Approximately 500

H.1.1.3. Retesting per Subtest – Approximately 500

H.1.1.4. Scoring Costs – Total Battery – Approximately 1,500

NOTE: GEDTS proposes to offer ODOC an annual license fee of \$114,000 that encompasses all the services as outlined below related to the paper-based test delivery of the new GED® test in OK correctional facilities.

Services include delivery of up to three (3) attempts per content area per student for up to 2,400 student tests. The number of 2,400 student tests was derived by multiplying 160 batteries x 15 uses per battery = 2,400 individual tests. The three (3) attempts per content area includes the initial test and up to two free retakes, as needed.

The number "2,400 student tests" also refers to the number of individuals each of whom would be entitled to take the entire battery (all content area tests) of the GED® test. In other words, if one student-inmate takes all four content areas (RLA, Math, Science and Social Studies, i.e., one battery), that would count as one usage against the license.

The annual license fee would also cover all associated printing, processing and shipping costs, such as the paper test battery fee, scoring, and ancillary form maintenance and processing, as well as other miscellaneous delivery, scoring and reporting services.

The annual license fee would be billed and payable in four (4) equal quarterly payments. This option will provide ODOC with a fixed fee to offset the unpredictability of the number of test-takers on paper testing.
