Description of Amendment:

Questions and Answers:

Question: I see that there are four products to be quoted on the Attachment B. Is there a way for a bidder to provide a bid for some of the products on that list and not all four, or is there a requirement for a sole source provider?

Answer: **The solicitation doesn't prevent bidders from providing a bid for some of the products listed on Attachment B.**

Question: I also did not see any quantities or delivery locations.

Answer: **B.4 says this is a firm, fixed price contract for indefinite delivery and indefinite quantity. B.6 lists the Authorized Users. These users are located throughout the State of Oklahoma. B.7 says there may be delivery to multiple destinations.**

Question: **Is this product going to be stored centrally at the Supplier's location?**

Answer: **B.19 states the Supplier shall maintain inventory to ensure compliance with delivery requirements set forth in this contract.**

Question: Is this per truckload pricing versus per pallet pricing?

Answer: B.4 states this is a contract for indefinite delivery and indefinite quantity. B.27 states the Suppliers are to list any type of volume discount offered with their solicitation response. Attachment B asks for a per bag price. Any other pricing parameters should be added to Attachment B below the per bag pricing areas.

Question: Freight – per location example – panhandle versus Antlers

Answer: B.7 states delivery may be required to multiple destinations. A.17 states that unless otherwise specified in the solicitation or awarding documents, all deliveries shall be F.O.B. Destination.

Question: Pallet pricing – any additional cost?

Answer: B.4 states this is a contract for indefinite delivery and indefinite quantity. B.27 states the Suppliers are to list any type of volume discount offered with their solicitation response. Attachment B asks for a per bag price. Any other pricing parameters should be added to Attachment B below the per bag pricing areas.
