GENERAL PROVISIONS** – With respect to purchasers in the United States, "John Deere" means Deere & Company, 1 John Deere Place, Moline, IL 61265, and with respect to purchasers in Canada, "John Deere" means John Deere Canada ULC, 295 Hunter Road, P. O. Box 1000, Grimsby, Ontario L3M 4H5. The warranties described below are provided by John Deere to the original purchasers of new Agricultural, Turf and Utility Equipment ("Equipment") purchased from John Deere or authorized John Deere dealers (the "Selling Dealer"). These warranties apply only to Equipment intended for sale in Canada and the US. Under these warranties, John Deere will repair or replace, at its option, any part covered under these warranties which is found to be defective in material or workmanship during the applicable warranty term. Warranty service must be performed by a dealer or service center located in Canada or the US, and authorized by John Deere to sell and/or service the type of Equipment involved (the "Authorized Dealer"). The Authorized Dealer will use only new or remanufactured parts or components furnished or approved by John Deere. Warranty service will be performed without charge to the purchaser for parts and/or labor. However, the purchaser will be responsible for any service call and/or transportation of Equipment to and from the Authorized Dealer's place of business (except where prohibited by law), for any premium charged for overtime labor requested by the purchaser and for any service and/or maintenance not directly related to any defect covered under these warranties. These warranties are transferable, provided an authorized John Deere dealer is notified of the ownership change, and John Deere approves the warranty transfer.

**B. WHAT IS WARRANTED** – Subject to paragraph C, all parts of any new Equipment are warranted for the number of months or operating hours specified below. Each warranty term begins on the date of delivery of the Equipment to the original purchaser, (except for certain agricultural tillage, planting, cultivating, harvesting, and application Equipment which may have a delayed warranty start date, but only if established by John Deere and noted by Selling Dealer on the Purchase Order). **Included In 5E Series Tractor and Compact Utility Tractor Powertrain Warranty - Engine:** cylinder block, cylinder head, valve covers, oil pan, emissions control components, timing gear covers, flywheel housing, and all parts contained therein. **Powertrain:** transmission, transmission case, differential and axle housings, clutch housings, MFWD front axle assembly, and all parts contained therein (does not include external drivelines, dry clutch parts, or steering cylinders). **SWEEPS, SHOVELS, PLOWSHARES, AND DISK BLADES:** A replacement part will be furnished without charge if breakage occurs and the amount of wear is less than the wear limits established by John Deere.

Dear Mr. Thomas:

Please find the details below addressing various requirements from RFP SW190:

- Page 12, paragraph C.7.1 – Deere & Company is not bidding a discount for parts for this RFP. Parts transactions will be between the John Deere dealer and the agency.
- Page 12, paragraph C.9.3 and– Supplier shall identify any websites that can be of assistance in calculating cost of items purchased.
  - Agencies can utilize the “Build Your Own” tool to build and price their desired equipment at current MSRP price. [https://configure.deere.com/cbyo/#/en\\_us/products](https://configure.deere.com/cbyo/#/en_us/products)
- Page 14, paragraph C.13 – Training
  - Upon delivery of the equipment by the John Deere dealer, the dealer will review how to operate the equipment as well as its safety features. If more extensive training is required, it will need to be arranged between the agency and the dealer.
- Page 14, paragraph C.14.4 – Vendor’s Return Policy
  - Outside a piece of equipment’s being defective, John Deere does not offer a commercial sales or commercial products return policy. However, as long as the equipment is under warranty, warranty service will be performed at no charge to the customer.
- Page 14, paragraph C.15 – Allowable Charges
  - Delivery will be FOB Destination.
  - The dealer may charge \$4.00 per loaded mile to deliver equipment from the dealership to the agency’s location. The charge will be clearly indicated on the quote and/or purchase order as a separate line item. Mileage will be calculated using Google Maps.
- Page 16, paragraph H
  - Although the contract resulting from this RFP will be current price, we have enclosed price pages with our response as a bench mark for pricing at the beginning of the contract. Specifications are listed on the first price page for each equipment model. The price pages can be found on the enclosed CD ROM.
  - We’ve enclosed a dealer list containing dealership names, addresses, phone and fax numbers per the RFP requirements. Dealer emails and dealer websites can be obtained by utilizing our “Dealer Locator” found at [www.JohnDeere.com](http://www.JohnDeere.com) at the top of the page. The agency can enter their zip code to obtain this information for the nearest dealer.
