**Description of Amendment:**

**A2:** Yes, we will be allowing PDF's to be submitted due to electronic signatures and other reasons.

**Q3:** I have all the insurance required by the bid, except Hired not owned. We do not require this in any way. This type of insurance is required for delivery or transport of equipment we do not own. We don't have hired but not owned insurance because we do not deliver equipment, we hire freight companies to make delivery of vehicles (they maintain the proper insurance). The only time we are in a vehicle we do not own is for purposes of repair and that is well covered by our garage keeps insurance. Please advise.
