Schwarze Industries, seller, provides warranty coverage to the original purchaser for all new equipment manufactured by Schwarze Industries, Inc. Schwarze-built sweepers are warranted to be free from defects in materials and/or workmanship under normal operating conditions, and when used in a proper application, for a period of twelve (12) consecutive months from the date placed into service, or twelve hundred (1200) hours of operation, whichever occurs first, provided all recommended maintenance is performed as scheduled.

**WHAT WE WILL DO:** Seller's sole obligation with respect to this Warranty shall be to replace or repair, at Seller's option, any part, parts or workmanship which may prove to be defective during the Warranty Period. Warranty work shall be performed at Seller's home office (1055 Jordan Road, N.E., Huntsville, Alabama 35811) or, at Seller's sole option, at the Schwarze authorized Dealer nearest to the purchaser's location.

**WHAT IS NOT COVERED:** This warranty shall not apply to damage or defects caused by negligence, carelessness, unauthorized repair work, use of unauthorized repair parts or to damage due to accident, misuse or abuse on the part of the purchaser or his or her or its servants, agents, representatives or employees, or to damage caused by acts of God. This Warranty shall not apply to routine maintenance, repair and adjustments, or to the wear parts, including but not limited to the following:

- A-Series & S-Series Sweepers:** flaps, drive belt, hoses, broom bristles, seals, low arms, throttle cable, fan housing liner, door trim, filters, light bulbs, tires, water nozzles, spray tips, screens, springs, switches, batteries, mud flaps and mirrors.
- M-Series Sweepers:** brooms, rubber sprockets, bearings, flaps, drive couplings, drag brush, caster wheels, light bulbs, tires, water nozzles, spray tips, belts, control cables, filters, switches, batteries, mud flaps and mirrors.

### WARRANTY DISCLAIMER

Except for the warranties stated herein, THERE ARE NO OTHER WARRANTIES, EXPRESSED OR IMPLIED, INCLUDING THE IMPLIED WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE. SELLER SHALL NOT UNDER ANY CIRCUMSTANCES BE LIABLE FOR SPECIAL, INCIDENTAL OR CONSEQUENTIAL DAMAGES SUCH AS, BUT NOT LIMITED TO, DAMAGE OR LOSS OF OTHER PROPERTY OR EQUIPMENT, LOSS OF PROFITS OR REVENUE, COST OF CAPITAL, COST OF PURCHASE OR REPLACEMENT GOODS, OR CLAIMS OF CUSTOMERS OF PURCHASER FOR SERVICE INTERRUPTIONS.

The remedies of the Purchaser set forth herein are exclusive, and the liability of Seller with respect to the manufacture, sale, delivery, resale, installation or use of any goods covered by or furnished under this Limited Warranty shall not, in any event, exceed the price of the goods upon which such liability is based. Any parts or accessories not manufactured by Schwarze are warranted only to the extent that the manufacturer's Warranty may be passed on to Purchaser, and such parts and accessories are not subject to this Warranty or to any other warranty, expressed or implied. The limitations of remedies to repair or replacement and the disclaimer of all special, incidental or consequential damages are intended to be separate and independent limitations of Seller's liability.

**HOW TO OBTAIN SERVICE:** If a problem that is covered by this Warranty develops with this Schwarze Sweeper during the Warranty Period, PURCHASER MUST NOTIFY THE SCHWARZE IN WRITING PRIOR TO THE EXPIRATION OF THE WARRANTY PERIOD OR WAIVE ALL CLAIMS. Purchaser must then deliver the unit, at Purchaser's expense and risk of loss during transport, to Seller's Huntsville, Alabama address, or to the nearest Schwarze Industries, Inc. authorized Dealer. In lieu of presenting the unit for service, parts covered under this Warranty will be shipped at Purchaser's expense if the total weight of the parts is less than 25 lbs. If the Purchaser agrees to pay \$10.00 over the normal freight charges, parts covered under this 12 Month Warranty will be shipped via air freight for next-day delivery, when available. Those parts not shipped on an expedited basis, or weighing more than 25 lbs, will be shipped by Seller's normal methods (U.P.S. ground, common carrier, etc.) at the Purchaser's expense unless Purchaser specifies differently, and agrees to be liable for any additional shipping and freight charges. All parts covered under Warranty will be shipped C.O.D. unless the Purchaser has previously established an account with Schwarze and provided that such account is not past due and that the Purchaser has not exceeded his/ her/its credit limit. Warranty credit will be available only on parts which are received by Seller within thirty (30) days of the Purchaser's receipt, and if the replacement or repaired part is returned freight prepaid, and only if the component manufacturer approves it for warranty replacement. In NO case will credit be available for defective parts received by Seller later than (30) days after Schwarze ships the replacement part.

**TRANSFER OF WARRANTY:** This Warranty is nontransferable without prior approval, in writing, by Schwarze Industries, Inc., 1055 Jordan Road, N.E., Huntsville, Alabama, 35811. To be considered, any Transfer request must include the following information.

- The vehicle identification number of the chassis.
  - Model and serial number of the sweeper
  - Original purchaser's name and address
  - Name and address of the current registered owner.
  - Name and address of the party to whom the Warranty is requested to be reassigned.
- No employee or agent of Seller is authorized to alter or extend this Warranty or to assume any other liability on Seller's behalf. Any alterations or extensions shall not be valid or binding upon Schwarze.
