Description of Amendment:

Question #1 and #2: I received the amendment notification. Thank you for extending the question period. I wanted to ask about EITA Compliance as listed in Section Four:

E.11.4. Section Four – EITA Compliance

Provide adequate information defining your products level of EITA compliance by providing a Voluntary Product Accessibility Template (VPAT) that indicates compliance of all products offered with the provisions of Section 508 of the Rehabilitation Act Amendments included in the Workforce Investment Act of 1998. Please complete the VPAT & Accessibility - OMES Form that is applicable. Attached for reference is the VPAT Instructions Template.

Supplier may provide a URL link to a website providing VPAT for products deliverables through resulting Contract.

Question #1: Can the VPAT & Accessibility – OMES form please be provided? I searched the website and can't find it.
Answer: OMES no longer provides the forms. The language in "E.11.3.4. Section Four-EITA Compliance" is replaced in its entirety with the following language:

"Provide adequate information defining your products level of EITA compliance by providing a Voluntary Product Accessibility Template (VPAT) that indicates compliance of all products offered with the provisions of Section 508 of the Rehabilitation Act Amendments included in the Workforce Investment Act of 1998.

Supplier may provide a URL link to a website providing VPAT for products deliverables through resulting Contract."

Our product may qualify for an exception, according to one form I did find – Form 055- Accessible Electronic and Information Technology Checklist and Acquisition Documentation, page 2:

Question #2: Can an exception be made for the VPAT requirement?

Answer: Yes, however, the language in "E.11.3.4. Section Four-EITA Compliance" is replaced in its entirety with the following language:

"Provide adequate information defining your products level of EITA compliance by providing a Voluntary Product Accessibility Template (VPAT) that indicates compliance of all products offered with the provisions of Section 508 of the Rehabilitation Act Amendments included in the Workforce Investment Act of 1998.
Supplier may provide a URL link to a website providing VPAT for products deliverables through resulting Contract."
