**Description of Amendment:**

a. This is to incorporate the following:

Q.1. On Attachment A, item 2.2, Multiparameter Sonde: are we able to only bid on the ICPMS portion of the bid only or are we required to bid the Multiparameter Sonde as well?

A.1. **Each vendor will be able to bid on the ICPMS portion only. They are not required to bid on the Multiparameter Sonde.**

Q.2. We can bid the ICP-MS, however you're also requesting a bid for a – "Multiparameter EXO1 Sonde" which is not our product. Is it acceptable to NO BID that portion and still be considered for the ICP-MS? Or, do we need to work with that sole source and request a bid from them to attach to our response?

A.2. **It is acceptable to no bid the Multiparameter Sonde. Bidding on the ICP-MS only is acceptable.**

Q.3. Please clarify: "Item 2.1.4.2 Quoted instrument to be compatible with vendor options for metals speciation." For this specification, do we need to quote our metals speciation system as an option or are they just asking if our ICPMS is compatible with our metals speciation system that we sell?

A.3. **No speciation equipment is requested on this bid.**

Q.4. Is it acceptable for us to "no bid" the analyzer portion of the bid and respond only to the items that we carry?

A.4. **Yes it is acceptable to no bid the analyzer portion of the bid and only respond to the items you carry.**
