

STATE OF OKLAHOMA STATEWIDE CONTRACT WITH KORMAN SIGNS INC

This State of Oklahoma Statewide Contract (SW0675) is entered into between the state of Oklahoma by and through the Office of Management and Enterprise Services and Korman Signs Inc ("Supplier") and is effective from June 28,2021.

Purpose

The State is awarding this Contract to Supplier for the provision of Vinyl Roll-Up Signs and Stands, as more particularly described in certain Contract Documents. Supplier submitted a proposal which contained no exceptions to the Solicitation This Contract memorializes the agreement of the parties with respect to negotiated terms of the Contract that is being awarded to Supplier.
