



STATE OF OKLAHOMA STATEWIDE CONTRACT WITH Coughlan Companies LLC dba Capstone

This State of Oklahoma Statewide Contract (SW0012) is entered into between the state of Oklahoma by and through the Office of Management and Enterprise Services and Coughlan Companies LLC dba Capstone ("Supplier") and is effective from September 1, 2021.

Purpose

The State is awarding this Contract to Supplier for the provision of Books, Periodicals, Multi-Media, and other publications as more particularly described in certain Contract Documents. Supplier submitted a proposal which contained no exceptions to the Solicitation. This Contract memorializes the agreement of the parties with respect to negotiated terms of the Contract that is being awarded to Supplier.

Now, therefore, in consideration of the foregoing and the mutual promises set forth herein, the receipt and sufficiency of which are hereby acknowledged the parties agree as follows:

1. The parties agree that Supplier has not yet begun performance of work under this Contract. Upon full execution of this Contract, Supplier may begin work. Issuance of a purchase order is required prior to payment to a Supplier.

If and to the extent any provision is in multiple documents and addresses the same or substantially the same subject matter but does not create an actual conflict, the more recent provision is deemed to supersede earlier versions.
