Fifth Amendment

This Fifth Amendment to Master Agreement OK-MA-145-010 (the “Fifth Amendment”) is made as of the date of last signature below, but made effective back to April 25, 2022, between the State of Oklahoma by and through the Office of Management and Enterprise Services in conjunction with NASPO ValuePoint and Motorola Solutions, Inc. This Fifth Amendment is a Contract Document in connection with Master Agreement OK-MA-145-010 (“OK-MA-145-010”).

This Fifth Amendment supplements and amends OK-MA-145-010 entered into by the parties, which is incorporated by reference. Unless otherwise indicated, capitalized terms used in this Fifth Amendment without definition shall have the respective meanings specified in OK-MA-145-010.

The purpose of this Fifth Amendment is to memorialize the previous name changes of Contractor. In Addendum No. 1, the parties revised the Master Agreement to reflect Contractor’s reincorporation and name change from Enforcement Video, LLC to WatchGuard, Inc. On October 31, 2019, WatchGuard, Inc. amended its legal name to WatchGuard Video, Inc. Then on April 25, 2022, Contractor WatchGuard Video, Inc., a wholly-owned subsidiary of Motorola Solutions, Inc., transferred and assigned to Motorola Solutions, Inc. all of its rights, title and interests in and to the assigned contracts, including OK-MA-145-010 and the accompanying Participating Addendums and Orders and Purchase Orders. No other changes are made.

On April 25, 2022, WatchGuard Video, Inc. assigned, transferred and conveyed to Motorola Solutions, Inc., and Motorola Solutions, Inc. received and accepted from WatchGuard Video, Inc., all of its rights, benefit and interest in, to and under OK-MA-145-010 and the accompanying Participating Addendums and Orders and Purchase Orders. All contracts have been and will be honored in their existing form, and all invoices will be issued as usual, reflecting the new name of Motorola Solutions, Inc.
