Charges will be based on the above hourly rate or fee for services provided by a Nurse on Demand LLC DBA NurseBridge, health care personnel. Periods of work completed less than one (1) hour will be computed on a pro rata basis to the nearest quarter (1/4) hour. Time worked in excess of the hourly limit mentioned in this section will be reviewed on a per case basis to determine if the hours worked will be authorized and paid by \_\_\_\_\_.

**Cancellations:** If \_\_\_\_\_ modifies or cancels an order less than four (4) hours prior to the start of a shift, Nurse on Demand LLC DBA NurseBridge, will bill \_\_\_\_\_ for four (4) hours at the established hourly rate or fee.
