**STATE OF OKLAHOMA AMENDMENT No. 1 TO STATEWIDE CONTRACT
AMENDMENT CONTRACT WITH PLATINUM VENTURES INC (CURTIS
RESTAURANT SUPPLYS).**

This Amendment No. 1 (“Amendment”) to Statewide Contract 0275 for Commercial, Correctional Kitchen Equipment (“Contract”) is effective on the date of the last signature below (the “Amendment Effective Date”) and is entered into between the State of Oklahoma by and through the Office of Management and Enterprise Services (“State”) and Ace Mart Restaurant Supply Company d/b/a Curtis Restaurant Supplys (“Supplier”). This Amendment supplements and amends the Contract effective June 9, 2023, including all supplements and amendments thereto. Unless otherwise indicated herein, capitalized terms used in this Amendment without definition shall have the respective meanings specified in the Contract.

For good and valuable consideration, the parties agree to amend the Contract as follows:

1. Platinum Ventures Inc has entered a transaction to which Ace Mart Restaurant Supply Company has acquired the assets of Curtis Restaurant Supply.
2. Ace Mart Restaurant Supply Company d/b/a Curtis Restaurant Supply will hereafter be the Supplier under the Contract.
3. In the event of a conflict between the terms and conditions hereof and the terms and conditions of the Contract, the specific terms set forth in this Amendment shall govern the subject matter herein.
4. Except as expressly modified in this Amendment, all terms and/or provisions of the Contract not addressed herein remain as executed by the parties in the Contract and remain in full force and effect.
5. This Amendment may be executed by electronic signature in counterparts (e-mail, facsimile or otherwise). The counterparts each of which shall constitute an original, but all of which together shall constitute one and the same instrument.
