

**FIRST AMENDMENT TO STATEWIDE  
CONTRACT WITH ENVIRONMENTAL  
SYSTEMS RESEARCH INSTITUTE, INC.**

This First Amendment to Oklahoma Statewide Contract /Esri Agreement 00320139.0 (the “First Amendment”) is effective as of the date of the last signature below, between the State of Oklahoma by and through the Office of Management and Enterprise Services (“State”) and **Environmental Systems Research Institute, Inc.** (“ESRI” or “Supplier”). This First Amendment supplements and amends the Statewide Contract /Esri Agreement 00320139.0, which was incorrectly reference as Statewide Contract No. 1014, entered into by the parties on December 28, 2023 (the “Contract”). The parties agree and understand the purpose of this *First Amendment* is to correct the error in which Statewide 1016 (“SW1016”) was erroneously referred to as Statewide 1014. Unless otherwise indicated, capitalized terms used in this *First Amendment* without definition shall have the respective meanings specified in the Contract.

For good and valuable consideration, the parties agree as follows:

1. This First Amendment incorporates by reference the *Contract* entered into on December 28, 2023.
2. The parties agree this *First Amendment* serves to:
  - a. Any reference to SW1014 in the contract, is hereby replaced with SW1016.
  - b. Memorialize the correction of the error in which Statewide 1016 (“SW1016”) was erroneously referred to as Statewide 1014; and
  - c. Memorialize the parties understanding that this *Contract* is pursuant to and will be governed by the terms and conditions of *SW1016*.
3. Except as expressly modified by this *First Amendment*, all terms or provisions of the *Contract* not addressed herein remain as executed by the parties and in full force and effect.
4. This *First Amendment* may be executed in multiple counterparts, each of which will be an original and together will constitute the same instrument.


