**FIRST AMENDMENT TO OKLAHOMA STATEWIDE CONTRACT
WITH AMAZON WEB SERVICES, INC.**

This First Amendment to Oklahoma Statewide Contract No. 1041 (the “First Amendment”) is effective as of the date of the last signature below, between the State of Oklahoma by and through the Office of Management and Enterprise Services (“State”) and Amazon Web Services, Inc. (“Supplier”). This First Amendment supplements and amends the Contract effective on June 3, 2024, including all supplements and amendments thereto. Unless otherwise indicated herein, capitalized terms used in this Amendment without definition shall have the respective meanings specified in the Contract.

For good and valuable consideration, the parties agree to amend the Contract as follows:

1. The Supplier and the State hereby agree to amend the Contract to revise Attachment B by modifying the Ordering, Inspection, and Acceptance Section 6, and to further amend the Contract to incorporate CJIS-related terms.

2. New Section 6.5 is added to include the following language:

“OMES is a required signatory for any Acquisition made by State entities within the executive branch.”

3. The disclaimer paragraph on the first page of Oklahoma Statewide Contract No. 1041 shall be revised to strike the following language, which were the final two sentences of that paragraph:

“Additionally, this Contract does not include the State’s CJIS Security Policy. Customer and Supplier may address the use of criminal justice information through further agreement.”

4. The following language shall be added as Attachment D Appendix 2 (which was previously removed in its entirety):

"AWS offers Services designed to enable Customers to comply with applicable requirements. Customers have a variety of options to choose from when configuring their AWS Account(s) for all sensitive or otherwise valuable Customer Content including Criminal Justice Information (CJI) that is subject to the Federal Bureau of Investigation (FBI) Criminal Justice Information Services (CJIS) Division Security Policy (the "CJIS Security Policy").


Provided Customer has properly configured the Service(s), deployed appropriate security protocols, and architected its AWS Account(s) as required to comply with the CJIS Security Policy, AWS will comply with the applicable terms of the CJIS Security Policy, including preventing AWS personnel from having physical or logical (electronic) ability, right or privilege to view, modify or make use of Criminal Justice Information (CJI) unless a security addendum has been signed, a national fingerprint-based background check has been completed, and the relevant AWS employee has been approved by the Oklahoma Department of Public Safety pursuant to the CJIS Security Policy, provided the foregoing is required by the CJIS Security Policy.

Notwithstanding the foregoing, in the event that Customer contracts for AWS Professional Services that requires AWS personnel to access Customer Content containing CJI, AWS acknowledges it may need to execute a separate addendum to the relevant Statement of Work to address applicable CJIS requirements, and require those AWS personnel with access to complete a national fingerprint-based background check has been completed, and the relevant AWS employee has been approved by the Oklahoma Department of Public Safety."

5. In the event of a conflict between the terms and conditions hereof and the terms and conditions of the Contract, the specific terms set forth in this Amendment shall govern the subject matter herein.
6. Except as expressly modified in this Amendment, all terms and/or provisions of the Contract not addressed herein remain as executed by the parties in the Contract and remain in full force and effect.
7. This Amendment may be executed by electronic signature in counterparts (e-mail, facsimile or otherwise). The counterparts each of which shall constitute an original, but all of which together shall constitute one and the same instrument.
