



Holiday, or work adjust) to cover the absence. Administrative Leave cannot be granted without an official reduction in services.

All regular classified and unclassified employees are eligible for administrative leave due to hazardous weather leave provided:

➤ Employees who are not responsible for providing basic minimum services (Non-Essential) and who were scheduled to work during the time period of the reduced services will use Administrative Leave (coded as "AE" and "AU" on the time/leave sheet). Non-Essential employees who are absent from work during the reduced services on any previously approved leave may not earn or use Administrative Leave.

➤ Employees who have been identified as responsible for providing basic minimum services (Essential) shall accrue administrative leave on a straight time basis for all hours worked during such a reduction (up to a maximum of 8 hours per day). Employees will not accrue administrative leave for work performed during overtime hours or on a holiday.

➤ Administrative Leave must be taken within 180 days of its accrual or the employee will be paid for the leave. Non-Essential employees who report to work will not accrue administrative leave.

➤ Essential employees who do not report to work during an authorized reduction of services may be charged with unauthorized absence or granted

the following options (in any combination) to account for the absence:

- a. Compensatory time (FLSA Exempt employees only)
  - b. Annual leave
  - c. Holiday
  - d. Make up the lost time in a manner consistent with the FLSA, if office hours and schedules permit.
- Temporary employees are not eligible for administrative leave and will not be paid for lost time unless it is made up.
