**BUSINESS CONDUCTED AT THE MEETING**

1. **BUSINESS CONDUCTED:** Consideration and action regarding the minutes of the meeting held January 24, 2012. **ACTION TAKEN:** Mr. Roth moved that the minutes of the meeting held on January 24, 2012, be approved. Mr. Curry seconded the motion. **ROLL CALL VOTE:** Mr. Prince-aye; Mr. Curry-aye; Mr. Roth-aye. Motion passed, 3-0.
