Determination of Quorum and Call to Order

The meeting was called to order at 1:05pm. Ms. Hall called the roll. Board members present were Ms. Susan McHugh, Dr. Mary Hudson, Dr. Christopher Goff, Mr. William Livermon, and Ms. Mona Ryan. A quorum was present.

Others present: Amy Hall, Executive Secretary and Sandra Balzer, Assistant Attorney General, Linda Sealey, Tracy Grammer and Jordan Spencer.

Welcome Dr. Christopher Goff to our Board. Dr. Goff was Appointed to serve from April 14, 2016 through August 17, 2018.

No action taken.

Approval of Minutes from May 6, 2016 and June 1, 2016 Board Meetings.

Mr. Livermon moved and Dr. Hudson seconded the motion to approve the May 6 board meeting minutes as written. Dr. Hudson, Ms. McHugh, Mr. Livermon, Dr. Goff and Ms. Ryan voted yes with a show of hands. Motion approved.

Mr. Livermon moved and Ms. Ryan seconded the motion to approve the June 1 board meeting minutes as written. Dr. Hudson, Ms. McHugh, Mr. Livermon, Dr. Goff and Ms. Ryan voted yes with a show of hands. Motion approved.

Discussion of Rule 690:15-1-5 Regarding Paying Supervisors for Supervision of Students.

Dr. Linda Sealey wanted to ask what the Boards opinion on the meaning of rule 690:15-1-5 (2) "Licensees should not accept compensation for supervision or sponsorship from persons being supervised or sponsored." Dr. Sealey questioned whether the rule applied to prohibit a supervising speech-language pathologist from receiving funds from a university grant program as an incentive to supervise university students. Ms. Balzer explained that a plain reading of the rule prohibits the supervising speech-language pathologist from accepting compensation only from the person being supervised. No action needed.

Ms. Balzer offered a proposed Consent Order in disposition of the complaint alleging the respondent failed to notify the Board regarding change of supervision. Respondent was not present. Mr. Livermon moved and Ms. Ryan seconded the motion to accept the Consent Order as proposed. Respondent agreed to complete a corrective action plan of reviewing the Board rules and ASHA rules to make a table comparing the two on requirements for licensure. Discussion and Possible Action Regarding Supervision Training Hours Required by Rule 690:10-5-6 and 690:10-7-3.

The Board discussed how to apply rules 690:10-5-6 and 690:10-7-3 which require licensees to complete 6 hours of training to be eligible to supervise clinical experience interns and speech-language pathology assistants. At least three of the six hours must specifically relate to the supervision of either clinical experience interns or SLP assistants. A licensee who wishes to supervise both clinical experience interns and SLP assistants may meet the requirement by obtaining three hours specific to clinical experience interns and three hours specific to SLP assistants. No action needed.
