Determination of Quorum and Call to Order

The meeting was called to order at 1:00pm. Ms. Hall called the roll. Board members present were Ms. Susan McHugh, Dr. Mary Hudson, Mr. William Livermon and Ms. Mona Ryan. A quorum was present.

Others present: Amy Hall, Executive Secretary and Sandra Balzer, Assistant Attorney General.

Welcome Dr. Christopher Goff to our board. Dr. Goff was appointed to serve from April 14, 2016 through August 17, 2018.

Discussion and Possible Action on Executive Order 2016-01 from Governor Mary Fallin. Stephanie Tomlinson from OMES will be presenting options.

Franklin Antao from OMES presented information and instructions on setting up voicemail and webmail for each Board member regarding Executive Order 2016-01. The cost will be \$4.65 per Board member a month starting July 1, 2016. Dr. Hudson moved and Ms. Ryan seconded the motion to use this OMES process that was proposed to the Board.
