Determination of Quorum and Call to Order.

The meeting was called to order at 1:02pm. Dr. Graham called the roll. Board members present were Dr. April Graham, Ms. Monica Benear, Ms. Christina Cid, Mr. Steve Garrett, and Dr. Rick Visor. A quorum was present.

Others present: Amy McPeek, Director, Sandra Balzer, Assistant Attorney General, Amy Laubach, Guest and Donald Oliva, Guest.

Welcome Dr. Misty Mann-Bolstad to our Board, appointed to serve from August 18, 2022 to August 17, 2025

No action taken.

Presentation from CE Broker, a CEU platform, and Discussion and Possible Action on becoming a member of CE Broker

Ms. McPeek introduced Mr. Oliva from CE Broker who discussed with the Board about the Continuing Education platform, how it works and the advantages of our Board becoming a member. Ms. Hall is going to contact other states who use the platform. Tabled until the next meeting.

Approval of Minutes from June 10, 2022 Board Meeting.

Ms. Cid moved and Ms. Benear seconded the motion to approve the June 10, 2022 board meeting minutes as written. Dr. Graham, Ms. Benear, Ms. Cid, Mr. Garrett and Dr. Visor voted yes by roll call. Motion approved.

Discussion and Possible Action on Recommendations Regarding Complaints Received by the Board: 21-01, 21-02, 22-04, 22-06, 22-07, 22-09, and 22-10

21-01 and 21-02

Ms. Balzer reported that 21-01 and 21-02 are still under investigation. No action needed.

22-04, 22-06 and 22-07

Ms. Balzer stated that the Board had previously voted to file formal complaints in these matters, but complaints have not yet been filed. No action needed

22-09

Ms. Balzer stated that there was sufficient evidence to find probable cause of a violation in this complaint. Ms. Benear moved and Ms. Cid seconded the motion to proceed with a formal complaint. Dr. Graham, Ms. Benear, Ms. Cid, Mr. Garrett and Dr. Visor all voted yes with roll call. Motion approved.

22-10

Ms. Balzer reported that 22-10 is still under investigation. No action needed.

21-04, Eveylin Wells, SP#2576

Ms. Balzer offered a proposed Consent Order in disposition of the complaint for failure to comply with the 2019-2020 CEU requirements. Respondent was not present. Dr. Visor moved and Ms. Benear seconded the motion to (1) accept the Consent Order as proposed, (2) find that respondent has satisfied the fine of \$42.50 and 1 of the 3 hours of ethics, (3) close the complaint and (4) should Ms. Wells attempt to renew her license she will be required to obtain 2 hours of ethics before she can renew. Dr. Graham, Ms. Benear, Ms. Cid, Mr. Garrett and Dr. Visor voted yes by roll call. Motion approved.

Discussion and Possible Action on Guidelines for the Scope of Practice for Speech-Language Pathologist and Audiologists

Ms. Benear moved and Ms. Cid seconded the motion to adopt ASHA's Speech-Language Pathology scope of practice and ASHA's Audiology scope of practice in addition to that established by the Board rules and statutes. The licensee must provide proof of training for any service that is outside the scope of practice. Dr. Graham, Ms. Benear, Ms. Cid, Mr. Garrett and Dr. Visor voted yes by roll call. Motion approved.

Discussion and Possible Action on Selection of Individuals to Attend the NCSB Conference Oct 13-15 in Santa Fe, New Mexico.

Ms. Cid moved and Mr. Garrett seconded the motion to send Dr. Misty Mann to NCSB. Dr. Graham, Ms. Benear, Ms. Cid, Mr. Garrett and Dr. Visor voted yes by roll call. Motion approved.
