Determination of Quorum and Call to Order.

Approval of Minutes from August 12, 2022 Board Meeting.

Ms. Cid moved and Dr. Visor seconded the motion to approve the August 12, 2022 board meeting minutes as written. Ms. Benear, Ms. Cid, Dr. Mann, Mr. Garrett and Dr. Visor voted yes by roll call. Motion approved.
