Determination of Quorum and Call to Order

The meeting was called to order at 1:07pm. Dr. Stanton called the roll. Board members present were Dr. Suzanne Stanton, Ms. Tracy Grammer, Dr. April Waller, and Mr. William Livermon. A quorum was present.

Approval of Minutes from February 21, 2020 Board Meeting

Mr. Livermon moved and Ms. Grammer seconded the motion to approve the February 21, 2020 board meeting minutes as written. Dr. Stanton, Ms. Grammer, Dr. Waller and Mr. Livermon voted yes by roll call. Motion approved.

Dr. Stanton, Ms. Grammer, Dr. Waller, Dr. Berryhill and Mr. Livermon voted yes by roll call. Motion approved.
