In conformity with the Oklahoma Open Meeting Act, advance notice of this board meeting was originally transmitted to the Oklahoma Secretary of State on November 1, 2016 at 11:05am; and, public notice of this meeting together with the agenda, was posted in prominent public view on the front door of the Office Building at 3700 N. Determination of Quorum and Call to Order

The meeting was called to order at 1:08pm. Ms. Hall called the roll. Board members present were Ms. Susan McHugh, Dr. Deborah Earley, Mr. William Livermon and Ms. Mona Ryan. A quorum was present.

Others present: Amy Hall, Executive Secretary, Sandra Balzer, Assistant Attorney General, and Suzanne Stanton, Speech-Language Pathologist.

Approval of Minutes from May 12, 2017 Board Meeting.

Mr. Livermon moved and Dr. Earley seconded the motion to approve the May 12 board meeting minutes as written. Dr. Earley, Ms. McHugh, Mr. Livermon and Ms. Ryan voted yes by roll call. Motion approved.

Discussion and Possible Action on Recommendations Regarding Complaints Received by the Board: 17-01 and 17-04

Ms. Balzer reported that 17-01 and 17-04 are both on the same licensee and they are still under investigation. No action was needed.

Discussion and Possible Action on Disciplinary Matters. The Board may conduct an evidentiary hearing, consider a proposed consent order, or consider other associated matters or motions. The Board may convene in executive session for deliberations pursuant to 25 O.S. Section 307(B)(8).

Mr. Livermon moved and Ms. Ryan seconded the motion to continue this matter to the August 25 Board meeting. Dr. Earley, Ms. McHugh, Mr. Livermon and Ms. Ryan voted yes by roll call. Motion approved.

Discussion and Possible Action on Licensees who are non-compliant with the Oklahoma Tax Commission: Paul Henderson, SP#2887, Belinda Henderson, SP#2875 and Deborah Young, SP#570

Ms. Hall addressed the Board concerning Paul Henderson, Belinda Henderson and Deborah Young not being tax compliant, but they did make timely renewal of their license for 2017. Mr. Livermon moved and Dr. Earley seconded the motion to table the renewal of Paul Henderson and Belinda Henderson until next Board meeting. Dr. Earley, Ms. McHugh, Mr. Livermon and Ms. Ryan voted yes by roll call. Motion approved. Mr. Livermon moved and Ms. Ryan seconded the motion to deny Deborah Youngs application for renewal. Dr. Earley, Ms. McHugh, Mr. Livermon and Ms. Ryan voted yes by roll call. Motion approved.

Discussion and Possible Action on Telepractice and License Portability.

Mr. Livermon has agreed to be on the subcommittee for ASHA regarding telepractice. Mr. Livermon asked for input from the Board regarding telepractice and license portability. The Board is supportive in the expansion of telepractice as it helps fill the need for services to schools in rural areas, but has concerns about the level of oversight those schools are able to provide for those service providers. The Board discussed the pros and cons of multi state licensure. No action needed.

Discussion and Possible Action on Over the Counter Hearing Aids Act of 2017.

The Board reviewed letters from NCSB and ASHA regarding their concerns with proposed federal legislation authorizing the sale of Over the Counter Hearing Aids. They both asked our Board to send letters to the members of the committees considering the legislation. Dr. Earley moved and Mr. Livermon seconded the motion to send a letter to the names listed on the email from ASHA. Dr. Earley, Ms. McHugh, Mr. Livermon and Ms. Ryan voted yes by roll call. Motion approved. Dr. Earley will write the letter for Ms. Hall to send.

Update on Statutory changes to the Speech-Language Pathology and Audiology Licensing Act.

The Governor vetoed the bill based on concerns regarding the constitutionality of the Boards authority to determine what constitutes a passing score on the exam. Ms. Ryan plans to meet with the Governor's office to discuss the Governor's concerns. No action needed.

Discussion and Possible Action on FY18 Budget.

Ms. Hall discussed with the Board the budget for FY18. We estimated our budget at \$209,000.00 for FY18. We increased our budget this year to include the costs of an audit and the need to hire a full-time assistant to replace our current part-time one. Mr. Livermon moved and Dr. Earley seconded the motion to accept the budget for FY18. Dr. Earley, Ms. McHugh, Mr. Livermon and Ms. Ryan voted yes by roll call. Motion approved.

Discussion and Possible Action on selection of individuals to attend the NCSB conference Sept 14-16 in New Orleans, Louisiana.

Mr. Livermon moved and Dr. Earley seconded the motion to send Ms. Suzanne Stanton to the NCSB conference in New Orleans, Louisiana. Dr. Earley, Ms. McHugh, Mr. Livermon and Ms. Ryan voted yes by roll call. Motion approved.

Discussion and Possible Action on Financial Reports.

Ms. Hall reviewed the financial reports for May 2017. No action needed.
