Determination of Quorum and Call to Order

The meeting was called to order at 1:12pm. Ms. Ryan called the roll. Board members present were Ms. Mona Ryan, Dr. Deborah Earley, Mr. William Livermon, Dr. Christopher Goff, and Dr. Suzanne Stanton. A quorum was present.

Approval of Minutes from March 30, 2018 Board Meeting

Mr. Livermon moved and Dr. Earley seconded the motion to approve the March 30, 2018 board meeting minutes as written. Ms. Ryan, Dr. Earley, Mr. Livermon, Dr. Goff, and Dr. Stanton voted yes by roll call. Motion approved.

a.18-06, Bethany Griffith, SP#3643. Consent Order

Ms. Balzer offered a proposed Consent Order in disposition of the complaint alleging practice with an expired license. Respondent was not present. Ms. Ryan discussed with Board that the written notification the Board receives from the Program directors as Proof of completion of academic requirement does not take the place of the official transcript and does not allow the office staff to issue a temporary license. A temporary license can only be granted if all required documents have been received. Ms. Balzer issued an informal opinion regarding this issue. No motion needed.
