Determination of Quorum and Call to Order

The meeting was called to order at 1:08pm. Dr. Stanton called the roll. Board members present were Dr. Suzanne Stanton, Dr. April Waller, and Dr. Wayne Berryhill. A quorum was present.

Approval of Minutes from August 16, 2019 Board Meeting

Dr. Berryhill moved and Dr. Waller seconded the motion to approve the August 16, 2019 board meeting minutes as written. Dr. Stanton, Dr. Waller and Dr. Berryhill voted yes by roll call. Motion approved.

Discussion and Possible Action on Disciplinary Matters. The Board may (1) conduct an evidentiary hearing; (2) consider a proposed consent order, or (3) consider other associated matters or motions. The Board may convene in executive session for deliberations pursuant to 25 O.S. Section 307(B)(8).

19-05, Barbara Crawford, SP#233. Proposed Consent Order

Ms. Balzer offered a proposed Consent Order in disposition of the complaint alleging practice with an expired license. Respondent was not present. Dr. Berryhill moved and Dr. Waller seconded the motion to accept the Consent Order as proposed. Respondent agreed to complete an ethics course, and an audit of her continuing education hours for the time period of January 1, 2019 to December 31, 2020. Dr. Stanton, Dr. Waller and Dr. Berryhill voted yes by roll call. Motion approved.

19-08

Ms. Balzer reported that 19-08 is still under investigation. No action was needed

Ms. Balzer stated that there was sufficient evidence to find probable cause of a violation in this complaint. Dr. Berryhill moved and Dr. Waller seconded the motion to proceed with a formal complaint. Dr. Stanton, Dr. Waller and Dr. Berryhill voted yes by roll call. Motion approved.

Discussion and Possible Action on Licensees who are Non-Compliant with the Continuing Education Requirements

Mary Barber, SP#2068

Ms. Hall informed the Board that Ms. Barber received proper notice that the audit of their continuing education revealed deficiencies. Per Board rules she was given notice of the opportunity to correct via a certified 30 day letter and a certified 90 day letter and she did not respond to the letters or submitted proof of correction of the deficiencies. Dr. Waller moved and Dr. Berryhill seconded the motion to file a formal complaint. Dr. Stanton, Dr. Waller and Dr. Berryhill voted yes by roll call. Motion approved.

Report from Suzanne Stanton from CSG Compact Summit.

Dr. Stanton presented to the Board information that was given at the CSG Compact Summit. No action taken.

Report from Tracy Grammer from NCSB Conference.

Ms. Grammer presented to the Board information that was given at the NCSB conference. No action taken.

Discussion and Possible Action on Rule 690:10-7-3 Regarding the Request of Calculated Hours in a Month Rather than a Week.

Ms. Hall sought input from the Board on a procedure for processing these requests. Dr. Waller moved and Ms. Grammer seconded the motion to have Ms. Hall prepare a form and authorize her to process any requests. Dr. Stanton, Dr. Waller, Ms. Grammer and Dr. Berryhill voted yes by roll call. Motion approved.

Discussion and Possible Action Regarding the Six Hours of Supervision Training CEUs.

After discussion, the Board confirmed that licensees whose six hours of supervision training consists of three hours specific to supervision of SLPAs and three hours specific to supervision of Clinical Fellows are compliant with the rule regardless of whether they supervise only SLPAs or only Clinical Fellows. No action needed.

Discussion and Possible Action to Determine Rulemaking Needs for 2020.

The Board held a general discussion of various issues that may necessitate rulemaking for 2020. Specific proposed rules will be presented for further consideration at the next Board meeting. No action taken.
