**2017 Nomination Form**

**Purpose:** The Oklahoma Women's Hall of Fame shall bestow the highest honor of outstanding service benefiting the lives of women and families in Oklahoma, the nation, or elsewhere in the world.

**Criteria:** Women involved in a particular discipline, profession or field who has made contributions of significant and recognizable change affecting the lives of women and families, regardless of whether the candidate is living or deceased.

**Eligibility:**

- Recipient must be a current or former resident of Oklahoma
- Recipient must have made recognizable and/or sustainable contributions impacting the lives of women and families in her community, the state, nation and/or globally.

As a guide for choosing a woman to nominate, consider the following questions:

- What enduring contributions has she made?
- How has she positively impacted women and girls?
- Is the community/state/nation or world better for the contributions of the nominee?
- Are people in general better because of the accomplishments of the nominee?
- Are women in the state, the region, the United States and/or world better? Has their status improved or opportunities increased because of the contributions of the nominee?
- Is her particular profession or field better because of the contributions of the nominee?

Various categories of disciplines, professions or fields may include but are not limited to: Arts, Business, Community Services, Public Service, Sciences
