CONTENT OF THIS BULLETIN: REVISED REPORTING INSTRUCTIONS AND REPORTING METHOD

EFFECTIVE DATE: DECEMBER 31, 2014

As required by the referenced statute, reporting entities shall file, between January 1 and March 15 of each year, a closed claim report that includes data for all claims closed in the preceding calendar year and any adjustments to data reported in prior years.

The purpose of this amendment is to allow the Oklahoma Insurance Department to gather more accurate and useful statistical information regarding costs associated with medical professional liability claims.

To implement this amendment, the Department has prepared the Medical Malpractice 2014 Report Instructions (attached). These instructions will provide guidance in preparing and submitting the required information. Please report for calendar year 2014 and subsequent years using this edition of the Report Instructions until the Department provides notice to do otherwise.

PLEASE NOTE THAT REPORTING THROUGH SERFF¹ WILL NO LONGER BE ACCEPTED.

The 2014 report must be submitted to the Department through the online reporting portal on the Oklahoma Insurance Department website <http://www.ok.gov/oid>
