
NOW ON THIS October 17, 2012, pursuant to issued requirements of the State of Oklahoma, pursuant to 59 OS 1000.3 et seq, there came on before the Kiefer Board of Trustees, at the Regular monthly meeting of said Board, the need to amend the Kiefer Zoning Code, as codified as Part 5, Building Regulations and Codes, of the Town of Kiefer, Oklahoma. Said Building Codes existing as previously codified by the Town of Kiefer, as the International Building Code, 2006 Edition, as codified in Chapter 1, Building Codes and Regulations; the International Plumbing Code, 2006 Edition, as codified ass Chapter 2; the International Electrical Code, 2006 Edition, as codified as Chapter 3; the International Gas Piping Code, 2006 Edition, as adopted as Chapter 4; the International Fuel Gas Code, 2006 Edition, as adopted as Chapter 5; the International Mechanical Code, 2006 Edition, as adopted in Chapter 7; the International Residential Code, 2006 Edition, as adopted in Chapter 8. Said ordinances being adopted by the Town of Kiefer and codified as those respective chapters in Part 6, Building Regulations and Codes, of the Kiefer Code of Ordinances.

Pursuant to the statutory requirements of the State of Oklahoma as referenced above in 59 OS 1000.3 et seq, the above ordinances of the Town of Kiefer are each hereby amended so as to be governed by, and meet the requirements of the International Codes as above stated, 2009 edition. Said Code of Ordinances shall automatically be amended to meet the requirements of any further changes in editions that may be so required by the State of Oklahoma without further modification or individual adoption by the Board of Trustees of the Town of Kiefer.

Upon proper vote by the Board of Trustees of the Town of Kiefer, IT IS SO ORDAINED:

Done at the regular meeting of the Board of Trustees of the Town of Keifer this October 17, 2012, and following said vote, upon second motion and vote being held, it was determined that an emergency existed where the safety and well being of the Town of Kiefer, requires that said ordinance go into effect immediately upon publication.
