MINUTES OF THE OPEN MEETING OF THE BOARD
January 22, 2011

An open meeting of the Board of Examiners of Psychologists was held at 9:00 a.m. on Saturday, January 22, 2011 at the Veterinary and Dental Board meeting room, 201 NE 38th Terrace, Suite 1 & 2, Oklahoma City, Oklahoma. In attendance were R. Hand, Ph.D., Chair of the Board; P. Fischer, Vice-Chair of the Board, T. Brian, Ed.D.; G. Hobson, Ph.D.; M. Cohn, Ph.D.; T. Vaughn, Ph.D.; K. Dean, member of the Board; T. Rose, Executive Officer; A. East, Administrative Assistant and M. Lane, Assistant Attorney General.

Dr. Hand announced that a quorum was present to conduct business. He confirmed with Ms. Rose that the meeting was filed with the Secretary of State and the agenda was posted in accordance with the Open Meeting Act.

The motion was made by Dr. Fischer and seconded by Dr. Hobson to approve the minutes of the November 12, 2010 open meeting of the Board as presented. The motion was passed. Hobson, Fischer, Cohn, Brian, Dean and Hand voted for the motion to approve the November 12, 2010 minutes.

In the matter of RFI 09-8, Ms. Lane has received some paperwork from the courts. In the matter of RFI 09-9, the Probable Cause Committee meeting is being scheduled. In the matter of RFI 10-1, the Probable Cause Committee meeting is being scheduled. In the matter of RFI 10-2, the investigator is completing the report. In the matter of RFI 10-6, an investigator needs to be appointed.

Dr. Hand reported on RFI 10-7; an informal meeting was held with the psychologist, Dr. Hand and Dr. Vaughn. Dr. Hand made a recommendation to close RFI 10-7 as no evidence of ethical violation was found. Dr. Brian made a motion to close RFI 10-7. Dr. Hobson seconded the motion and the motion passed. Hobson, Fischer, Cohn, Brian, Dean and Hand voted to close RFI 10-7 as there was no ethical violation.

Dr. Hand reported on RFI 10-8; an informal meeting was held with the psychologist, Dr. Hand and Dr. Vaughn. Dr. Hand made a recommendation to close RFI 10-8 as no evidence of ethical violation was found. Dr. Hobson made a motion to close RFI 10-8. Dr. Fischer seconded the motion and the motion passed. Hobson, Fischer, Cohn, Brian, Dean and Hand voted to table Dr. Rouse's quarterly report and request that Dr. Rouse come into the Board office clarify the quarterly report.

Ms. Lane reported on the injunction filed against Dr. Jay Ferraro.

Ms. Lane reported on the website of Chris O'Banye. Ms. Lane met with Mr. O'Banye's attorney. Mr. O'Banye has since removed all references to him being a licensed clinical psychologist. The web address still states that he is a clinical psychologist.

Ms. Lane reported on the status of the possible Consent Order terms for Dr. Lashley's Board Complaint BC10-4.

The Board discussed possible rule and statute changes. Dr. Hobson made a motion to submit intent to change the Board rules Chapter 1, Sections 575:1-1-2, 575:1-1-3 and 575:1-1-4 and Chapter 10, Sections 575:10-1-2, 10-1-6, 10-1-8 and 10-1-9. Dr. Brian seconded the motion and the motion passed. Hobson, Fischer, Cohn, Brian, Dean and Hand voted for the motion to submit intent to change the Board rules Chapter 1, Sections: 575:1-1-2, 575:1-1-3 and 575:1-1-4 and Chapter 10, Sections 10-1-2, 10-1-6, 10-1-8 and 10-1-9. Dr. Fischer made a motion to have Dr. Hand appoint a committee to review rules and statutes and suggest changes to be reviewed at the next meeting of the Board. Dr. Brian seconded the motion and the motion passed. Hobson, Fischer, Cohn, Brian, Dean and Hand voted for the motion to have Dr. Hand appoint a review committee for the rules and statutes.
