MINUTES OF THE OPEN MEETING OF THE BOARD
July 25, 2009

An open meeting of the Board of Examiners of Psychologists was held at 9:00 a.m. on Saturday, July 25, 2009 in Room 419C of the State Capitol, 2300 N. Lincoln, Oklahoma City, Oklahoma. Dr. Miller announced that a quorum was present to conduct business and that the meeting was filed with the Secretary of State and the agenda was posted in accordance with the Open Meeting Act.

Dr. Vaughn reported on the status of the complaint filed by the Board regarding the APA Accreditation.

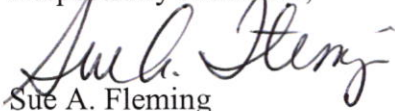
