MINUTES OF THE OPEN MEETING OF THE BOARD
September 19, 2009

An open meeting of the Board of Examiners of Psychologists was held at 9:00 a.m. on Saturday, September 19, 2009 in Room 419C of the State Capitol, 2300 N. Lincoln, Oklahoma City, Oklahoma. In attendance were T. Brian, Ed.D., Chair of the Board, R. Hand, Ph.D., Vice-Chair of the Board, C. Kilpatrick, Ph.D., P. Fischer, Ph.D. and G. Hobson, Ph.D. members of the Board; S. Fleming, Executive Officer, T. Rose, Administrative Assistant, T. Vaughn, Ph.D., Director of Professional Affairs and G. Harris, Assistant Attorney General. F. Rubin, DDS and K. Dean, Ph.D. were not present.

Dr. Brian announced that a quorum was present to conduct business and that the meeting was filed with the Secretary of State and the agenda was posted in accordance with the Open Meeting Act.

Grethen Harris was introduced as the new Assistant Attorney General representative to the Board, Dr. Pam Fischer was introduced as a new Board member replacing Dr. Miller and Teanne Rose, Administrative Assistant was introduced as the next Executive Officer for the Board when Sue Fleming retires in December.

The motion was made by Dr. Hobson and seconded by Dr. Kilpatrick to approve the minutes of the July 25, 2009 open meeting of the Board as presented. Hobson, Fischer, Kilpatrick, Hand and Brian voted for the motion.

The motion was made by Dr. Kilpatrick and seconded by Dr. Hobson to table the review of the scholarly paper presented by Dr. Wendy Huckeba in relation to BC 06-1 until the next meeting of the Board since it was received too late for the Board to review the material ahead of time and to accept the letter from Dr. Crews regarding her supervision of Dr. Huckeba. The motion passed. Hobson, Fischer, Kilpatrick, Hand and Brian voted for the motion.

Sue Fleming reported that she was still trying to find a supervisor for Dr. Britz in relation to BC07-3.

The Board reviewed the report from Dr. Washington in regarding to his supervision of Dr. Keithley in relation to BC07-5, as well as the scholarly paper submitted by Dr. Keithley. The motion was made by Dr. Kilpatrick and seconded by Dr. Hand to accept the paper as partial fulfillment of the Board's order in relation to BC07-5. The motion passed. Hobson, Fischer, Kilpatrick, Hand and Brian voted for the motion.

The motion was made by Dr. Kilpatrick and seconded by Dr. Hobson to deny the application for CPE credits for the workshop entitled "Stepfamilies: An Innovative Approach" sponsored by the Stillwater Interfaith Counseling Center scheduled for October 3, 2009, since it was not targeted towards the professional audience. The motion passed. Hobson, Fischer, Kilpatrick, Hand and Brian voted for the motion.

The motion was made by Dr. Fischer and seconded by Dr. Kilpatrick to deny the application for CPE credits for the workshop entitled "Resourcing the Body in Psychotherapy" sponsored by The Centreworks, scheduled for October 5, 12, 19 and 26, 2009, due to the absence of psychological basis. The motion passed. Hobson, Fischer, Kilpatrick, Hand and Brian voted for the motion.

The motion was made by Dr. Kilpatrick and seconded by Dr. Hand to deny the application for CPE credits for the workshop entitled "Working with Children: A Bioenergetic Approach to Play Therapy" sponsored by The Alexander Lowen Foundation, scheduled for October 23 & 24, 2009, since it was not targeted towards the professional audience. The motion passed. Hobson, Fischer, Kilpatrick, Hand and Brian voted for the motion.

Dr. Tom Vaughn discussed the *ASPPB Guidelines on Practicum Experience for Licensure*, and possible distribution to training committees in order to receive comments. The item will be addressed again at the next open meeting of the Board scheduled for November 21, 2009.

Dr. Tom Vaughn announced that he is scheduling a Jurisprudence Committee meeting to address the new law changes soon, and another Oral Examination Committee meeting to redo the exams that had problems at the June orals.

The Board will not have rule changes for 2009.

The motion was made by Dr. Hobson and seconded by Dr. Hand to approve hiring an Administrative Assistant for half time at \$12.00 per hour with benefits to replace Teanne Rose when she replaces Sue Fleming as Executive Officer. The motion passed. Hobson, Fischer, Kilpatrick, Hand and Brian voted for the motion.

The Board reviewed the request by Dr. Jane Epperley to apply an overage of CPE hours towards the next CPE year. The motion was made by Dr. Hobson and seconded by Dr. Kilpatrick to deny Dr. Epperley's request since it would require a rule change. The motion passed. Hobson, Fischer, Kilpatrick, Hand and Brian voted for the motion.

The motion was made by Dr. Hobson and seconded by Dr. Hand to adjourn the meeting. The motion passed. Hobson, Fischer, Kilpatrick, Hand and Brian voted for the motion.

The meeting adjourned at 12:45 p.m.
