MINUTES OF THE MEETING OF THE BOARD
October 7, 2022

A Meeting of the Board of Examiners of Psychologists was held at 9:00 a.m. on Friday, October 7, 2022. The meeting was held at the Colcord Center, 421 NW 13th Street, Suite 125, Oklahoma City, OK 73103.

In attendance were: K. Ward, Ph.D., Vice-Chair of the Board; K. Peters, Member of the Board; S. Sternlof, Ph.D., Member of the Board; A. Ivy, Member of the Board; R. Pollard, Member of the Board; K. Choate, Ph.D., Member of the Board; B. Warren, Assistant Attorney General; T. Rose, Executive Officer of the Board.

Not present: C. Grundy, Ph.D., Chair of the Board

Announcement and Introduction:

Dr. Ward announced that a quorum was present to conduct business. She confirmed with Ms. Rose that the meeting was filed with the Secretary of State and the agenda was posted in accordance with the Open Meeting Act.

Statement of the Mission of the Oklahoma State Board of Examiners of Psychologists:

Dr. Ward announced the mission of the Oklahoma State Board of Examiners of Psychologists is to protect the public by regulating the practice of psychology in Oklahoma to ensure that only properly qualified psychologists practice psychology in the state and that the psychology profession as a whole is conducted in the public's best interest.

Minutes:

Status of Current Request for Inquiries:

Ms. Rose provided a status update for the following Request for Inquiries (RFI's):

RFI 22-3; Investigation is pending.

RFI 22-5; Pending additional information.

Probable Cause Committee Summaries and Recommendations:

As a member of the Probable Cause Committee, Dr. Ward recused and left the room.

RFI 22-2; On behalf of the Probable Cause Committee, Ms. Warren provided a recommendation to the Board. An investigator was appointed. After careful review of all of the evidence, the committee determined there does not appear to be an ethical violation in

this matter and recommends that RFI 22-2 be dismissed, and the file closed. *Dr. Sternlof made a motion to accept the recommendation of the committee. Dr. Choate seconded the motion and the motion passed. Choate, Peters, Ivy, Sternlof, and Pollard voted for the motion. As a member of the Probable Cause Committee, Dr. Ward was not present.*

Dr. Ward returned to the room.

RFI 22-6; Ms. Warren provided a recommendation to the Board. After careful review of RFI 22-6 and the written response from the psychologist, it was determined that the inquiry did not reach the legal threshold necessary to warrant the Board taking formal action. Accordingly, the recommendation is to dismiss and close RFI 22-6, with no ethical violations. *Mr. Peters made a motion to accept the recommendation. Ms. Pollard seconded the motion and the motion passed. Ward, Choate, Peters, Ivy, Sternlof, and Pollard voted for the motion.*

Complaints, Orders, and Miscellaneous Disciplinary Matters:

BC20-4 Raymond Fuchs, Ph.D. – *Dr. Choate made a motion to set the hearing date for BC20-4 to November 18, 2022, at 10:00 am. Ms. Pollard seconded the motion and the motion passed. Ward, Choate, Peters, Ivy, Sternlof, and Pollard voted for the motion.*

Unlicensed Complaint - UC 22-3; Board members reviewed an inquiry, UC 22-3, that was received in the Board office concerning an individual that is not licensed as a psychologist. After careful review, *Dr. Sternlof made a motion to dismiss UC 22-3. Dr. Choate seconded the motion and the motion passed. Ward, Choate, Peters, Ivy, Sternlof, and Pollard voted for the motion.*

Report from Tom Brian, Ph.D. regarding remote telepsychology supervision:

Dr. Brian provided information to the Board regarding his report on remote telepsychology supervision. After discussion, Dr. Choate, Dr. Sternlof, Dr. Brian, and Ms. Rose will meet as a committee to gather more information to determine what steps should be taken next.

Texas State Board of Examiners of Psychologists request to consider entering into an Reciprocity Agreement with Oklahoma:

Ms. Rose informed the Board that she met with the Darrel Spinks, Director of the Texas State Board of Examiners of Psychologists. During their meeting, Mr. Spinks asked if Oklahoma would be interested in entering into a Reciprocity Agreement with Texas. Following discussion, *Dr. Sternlof made a motion to move forward with the process to enter into a Reciprocity Agreement with the Texas State Board of Examiners of Psychologists. Dr. Choate seconded the motion and the motion passed. Ward, Choate, Peters, Ivy, Sternlof, and Pollard voted for the motion.*

Applications approved by the Application Review Committee (July – September 2022):

Dr. Choate made a motion to ratify the applications approved by the review committee July – September 2022. Mr. Peters seconded the motion and the motion passed. Ward, Choate, Peters, and Pollard voted for the motion. Ivy and Sternlof abstained from the vote.

Executive Officer’s P-Card Statements for Review and Approval (July– September 2022):

Dr. Choate made a motion to approve the Executive Officer’s July – September 2022 P-Card Statements. Dr. Ivy seconded the motion and the motion passed. Ward, Choate, Peters, Ivy, Sternlof, and Pollard voted for the motion.

Public Comment:


Dr. Ward opened the meeting for public comment. One comment was heard.
