AN ORDINANCE DETACHING TERRITORY FROM  
THE CORPORATE LIMITS OF THE CITY OF DURANT,  
OKLAHOMA, AND DECLARING AN EMERGENCY

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF DURANT, OKLAHOMA:

SECTION 1: That Ordinance No. 1469 is hereby repealed and the territories described in Durant City Ordinance No. 1469 shall be detached from the corporate limits of the City of Durant, Oklahoma. That the City Council has determined that it is in the best interest of the inhabitants thereof and will redound to the benefit of the City of Durant and the inhabitant thereof for the same to be detached as a part of corporate limits of the City of Durant, Oklahoma (11 O.S. § 21-110). Therefore, the City Council does hereby detach and deannex said properties.


SECTION 2: That the zoning code and Annexation Map affected by the passage of Ordinance 1469 shall be properly corrected by the City Clerk.


