

ORDINANCE NO. 3110

AN ORDINANCE RELATED TO ANNEXATION, EXTENDING THE CITY LIMITS OF THE CITY OF GUTHRIE, OKLAHOMA TO INCLUDE THE TERRITORY HEREINAFTER DESCRIBED IN THIS ORDINANCE, SAID TERRITORY BEING LOCATED IN THE COUNTY OF LOGAN, STATE OF OKLAHOMA.

Whereas, the territory hereinafter described in this ordinance is contiguous with and adjacent to the city limits of the City of Guthrie, Oklahoma: and

Whereas, in the judgment and discretion of the City of Guthrie, it will redound to the benefit of said City to add to said City and increase the city limits; and

Whereas, the City of Guthrie has attained the written consent of the owners of the area to be annexed and all actions have been taken which are necessary to empower the City of Guthrie, Oklahoma, to annex the hereinafter described tracts of land and the City Council of the City of Guthrie, Oklahoma, finds all of the above true and correct.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF GUTHRIE:


SECTION 1. The corporate limits of the City of Guthrie are hereby extended and increased to include and there is hereby annexed and added to said City the following described territory located in Sections Two (2), Three (3) and Ten (10), Township 16 North, Range 2 West of the Indian Meridian, Logan County, Oklahoma, to-wit:

Commencing at a Point in the Centerline of Interstate 35 thirty-three (33) feet North of the South Sectionline of Section 3; thence East and parallel to said Sectionline to a point thirty-three (33) feet North and 33 feet East of the Southwest Corner of Section 2, T16N, R2W of the I.M.; thence N 00° 25'18" W, a distance of 1,246.08 feet, more or less, to a Set PK; thence S 89° 56'36" E a



distance of 594 feet, more or less, to a Set 3/8" Iron Rod; thence N 00° 25'18" W, a distance of 36.82 feet, more or less, to a Set 3/8" Iron Rod, thence S89° 51'05" E a distance of 2,020.86 feet, more or less, to a Set 3/8" Iron Rod; thence S 00° 25'23" E, a distance of 1,354.16 feet, more or less, to a point 33 feet South of the Southeast corner (SE/c) of the Southwest Quarter of said Section 2; thence West, a distance of 2,680.95 feet to a Point thirty-three (33) feet South and thirty-three (33) feet West of the Northeast Corner of Section 10, 16N, R2W of the I.M.; thence South a distance of 288 feet; thence West a distance of 267 feet; thence South a distance of 174 feet; thence West to the Centerline of Interstate 35 being 495 feet South of the North Sectionline of said Section 10, Logan County, Oklahoma.






