

ORDINANCE 03-04

AN ORDINANCE DE-ANNEXING FROM THE CITY OF LAWTON, OKLAHOMA, THE HEREINAFTER DESIGNATED AREA, THEREBY ALTERING, DIMINISHING AND ESTABLISHING THE CORPORATE LIMITS OF THE CITY OF LAWTON, OKLAHOMA AND DECLARLING AN EMERGENCY.

Emergency Ordinance

WHEREAS, in the opinion of the Council of the City of Lawton, Oklahoma, it is desirable to diminish the limits of said City by de-annexing the hereinafter described parcel of land, and

WHEREAS, the Council of the City of Lawton, Oklahoma, in its judgment finds that the de-annexation of said parcel of land will redound to the benefit of the City of Lawton, Oklahoma, and

WHEREAS, authority is vested in the City Council of the City of Lawton, Oklahoma, according to Title 11, Section 21-110, Oklahoma State Statutes, 2001, to diminish and alter the corporate limits of said City of Lawton in such manner as to exclude said area,

NOW, THEREFORE, be it ordained by the Mayor and the City Council of the City of Lawton, Oklahoma, that:

SECTION 1. The following described tract of land now included within the corporate limits of the City of Lawton, Oklahoma, to-wit:

All of the Southeast Quarter (SE1/4) of Section 17, Township One (1) North, Range Twelve (12) West of the Indian Meridian, Comanche County, Oklahoma;

The North Thirty-three (33) feet of the Northeast Quarter (NE1/4) of Section Twenty (20), Township One (1) North, Range Twelve (12) West, I.M., Comanche County, Oklahoma;

The East Thirty-three (33) feet of the Northeast Quarter (NE1/4) of Section 17, Township One (1) North, Range Twelve (12) West, I.M., Comanche County, Oklahoma; less and except the North 33 feet of said Northeast Quarter;

The West Thirty-three (33) feet of Section 16, Township One (1) North, Range Twelve (12) West, I.M., Comanche County, Oklahoma; less and except the North 33 feet of said West 33 feet.

The North Thirty-three (33) feet of the West Thirty-three (33) feet of Section 21, Township One North (T1N), Range Twelve West (R12W), I.M. Comanche County, OK.

be and is hereby de-annexed from the corporate limits of the City of Lawton, Oklahoma.


SECTION 2. That the limits or boundary of properties included within the corporate limits of the City of Lawton, Oklahoma, as they are now constituted be and they are hereby altered, diminished and modified so as to exclude the above described property, and same shall henceforth and hereinafter no longer be a part of the City of Lawton, Oklahoma.


